General:

- 1. The sale will accept performance type horses of any breed from yearlings to 3 years old.
- 2. All horses will have a Pre-purchase Health Exam by a Veterinarian for condition, blemishes and overall health; this will be done in a scheduled order. Comprehensive Health Exams will be at the expense of the buyer, there will be a Veterinarian onsite. Northlands reserves the right to accept or reject any entry. If an entry arrives lame or in poor condition, the consignor will be turned away, and he/ she will forfeit his/her entry fee. All decisions made by Northlands will be final. If a horse is lame prior to November 1st, a substitution can be made upon approval from Northlands.
- 3. A Manifest must be provided to Northlands upon arrival on grounds.
- 4. The "Terms & Conditions" are subject to change by action of Northlands.
- 5. Photographs can accompany the entry for the sale catalogue or emailed to <u>agriculture@northlands.com</u> by October 1st, 2017.

Payment of Entry Fees:

- Consignment Fee: \$250.00 (plus GST)*
 *Consignment fee includes one (1) parking pass, two (2)
 - *Consignment fee includes one (1) parking pass, two (2) exhibitor passes, two (2) bags of shavings, one (1) 10' x 10' box stall. Assigned stalling will be in Hall A, Edmonton Expo Centre. Additional shavings will be available for purchase. It is the owner's responsibility to ensure payment of entry fees are received by the entry deadline date. Payments returned due to insufficient funds will constitute an incomplete entry.
- 2. Entry fee(s) are payable by cheque, Visa or MasterCard.

Bloodstock Sale Terms & Conditions

1. All registered horses must be registered in the consignors name on the original registrations papers available by the date of the sale. If this does not happen, the horse will be sold as a grade.





- 2. Each horse in the sale must be left with halter and lead rope for the buyer.
- 3. Reserve will be accepted. Reserve price must be given to the Northlands Agriculture Department at the time of entry or at the time of arrival.
 - A consignor package will be emailed out in October of 2017.
- 4. Consignors will pay a 5% Commission on horses sold or on the reserve should the horse not sell.
- 5. Catalogue order will be determined by Northlands. Sale order will follow the catalogue order.
- 6. All horses are sold "as is" with all existing conditions and defects except as expressly provided below or as announced otherwise by the consignor or from the auction block. Any and all guarantees made by the consignor are made solely between the consignor and buyer.
- 7. The accuracy of all information in the catalogue is the sole responsibility of the consignor, as the certainty that all announcements regarding the catalogue changes or warranties are made while the horse is in the auction arena. Northlands, or any representative thereof, does not assume responsibility or liability for errors or omissions, or for any verbal or written statement regarding the animal sold.
- 8. Consignor does represent and warrant unto sale management and the buyer of each horse the following unless otherwise announced at time of sale. The horse is sound of eyes, wind and limb; The horse is not a "Cribber"; The horse has not been nerved nor has navicular disease; The sex of the horse is as described in the catalogue; The horse is not a cryptorchid nor ridgeling; The horse does not possess the defect commonly known as "Parrot Mouth"; Title of the horse is free from all adverse claims of ownership, use, or possession and consignor agrees to defend the title against all claims; Northlands is not responsible for buyer or consignor misunderstanding. Northlands strongly encourages all consignors to provide a copy of a Coggins Test that has been completed within 6 months.
- 9. After a horse has been consigned, consignor agrees not to dispose of the horse in a private sale. Withdrawals will be permitted on hardship cases but must be presented in writing to Northlands and be accompanied by a signed Veterinarian Certificate stating that the horse has either died, received injury which affects the horse's marketability, or has acquired an illness which prevents the horse from meeting the proper health requirements. There will be no refund of the consignment fee.
- 10. Consignor fully understands and agrees that payment from Northlands for horses sold will take place provided all the paperwork is complete and in order, or no other extra-ordinary controversy has arisen about the sale of the horse.
- 11. Any horse with incomplete paperwork after the sale will be charged 100% commission, until complete paperwork is remitted. Signed transfer must be received to Northlands by the sale day. The seller will not receive payment until paperwork is received.
- 12. Certificate of Registration must accompany entry fee and must be in the consignor's name.
- 13. Original registration certificate and other pertinent forms will be held by Northlands until the buyer's payment clears the drawee's bank and becomes unconditional credit.
- 14. Northlands reserves the right to cancel, transfer or reschedule the Bloodstock Sale without notice and/or liability. In the event of cancellation, all entry fees paid to date will be refunded. Any interest earned on the entries is the property of Northlands.
